Addendum 1:

ARTICLE II - OFFICERS

Section 1 - The officers of this club shall be: **Trustee**, President, Vice President, Secretary and Treasurer.

Section 2 - The officers of this club shall be elected for a term of one year, by ballot of the members present provided there be a quorum, at the annual meeting. A person must be a full member in good standing of the corporation at the time of their nomination and election and shall continue their membership during the time served holding any office. The term of the trustee is ongoing. A new trustee will be elected only when there is a vacancy.

Section 5 - The Trustee will be the trustee of record with the club's FCC license(s). This person will hold an Amateur Extra Class license. They will be responsible that the club's equipment and callsign are used according to the FCC rules and common amateur radio operating practices. If anyone desires to use the club's callsign(s) for any event, they must obtain permission from the club's trustee first.
